## **Election: November 1, 2005**

The Garden Oaks Maintenance Organization (GOMO) is holding an election for additional Directors in Garden Oaks Sections 1, 2, 3, and 5 (One Director for Section One, one for Section Two, three for Section Three, and two for Section Five).

Any Garden Oaks property owner in sections One, Two, Three, or Five may volunteer or otherwise be nominated for election to a vacant Director's position in GOMO from their section, subject to the restrictions below:

- Must be at least 18 years of age
- Must reside in Garden Oaks
- Must own property and live within the Garden Oaks section for the Director's position that you are volunteering to stand election for
- All property owned in Garden Oaks must be in compliance with the Garden Oaks Deed Restrictions, excluding violations that existed before your ownership of the property
- Must sign the attached statement attesting to the above

These elected Directors will serve starting on November 5th, 2005, for three (3) year terms.

If you would like to volunteer or otherwise be nominated, please fill out the Nominations form on the back of this flyer, and return it to the address listed on the form. Volunteer Nominations must be received before October 31, 2005 to be included on the ballot.

The elections will take place on November 1, 2005, immediately after the November GO Civic Club meeting (around 8 PM). Final vote results may not be announced until the ballots have been verified..
