### GOCC 2024 accomplishments and 2025 goals *Mike Stephens, GOCC President*

Hello neighbors! It is definitely cliché to talk about how time flies, but WOW, it seems like I was just writing the Gazette article to introduce myself as the new Garden Oaks Civic Club (GOCC) President, and now I'm thinking back on the full year that has passed.

For me, the experience as GOCC President in 2024 was a steep learning curve, but also rewarding, as I learned about how many long-time, dedicated volunteers we have in Garden Oaks. Yet, I also learned how hard it is to connect with the other hundreds of households that aren't aware of the civic club, and its importance in maintaining the things many may take for granted, like our dedicated Constable, or our beautiful parks.

In a year where the city experienced two significant storms, one of the most pleasing discoveries for me was that the City Council members who represent Garden Oaks are very involved with issues that impact our community. Representatives from their offices are present at most monthly GOCC meetings; they also come to our social functions, and they are also very responsive to issues that show up in their email inboxes.

#### Other successes and developments for GOCC in 2024:

- We developed a direct line of communication and a relationship with CenterPoint representatives in order to get better responses and problem solving specific to Garden Oaks. This was mainly due to aggressive and tactful interaction by some active residents. We still have a long way to go, but there has definitely been progress.
- We took the "rebranding" baton from the previous GOCC officers and continued moving forward, now focusing on neighborhood entry signage. One of the most significant developments was the introduction, guidance, and needed support from our City Council members to the Grant Program that exists, where the City provides financial support for projects just like this.
- We, once again, held successful fundraising events, including the Wakefield Shuffle and the Azalea Street Beer & Wine Extravaganza; both were essential for providing some of the funding necessary for the Constable program and the other functions of our civic club.
  - We held the first Garden Oaks neighborhood-wide garage sale, which had great participation.
- We've supported the volunteers who are working through the challenging process of reviving the Home Owners Association for Garden Oaks.
- We expanded our social media activities on Facebook (Houston\_GO) and Instagram (@gardenoakshouston) in an effort to reach residents who may not see neighborhood news via email, or in the Gazette.

Deputy Constable Kelley briefly reminded homeowners to use Vacation Watch service if out for the holidays. She also mentioned that "porch pirate" incidents are high, due to the holidays. She encouraged people to be vigilant about reporting suspicious people to the Constable and to promptly retrieve your packages from the porch.

Mike reminded all that the social media and Event coordination roles (both currently handled by Emily) will be split in 2025, and that we're in desperate need of volunteers to assist with event planning.

Mike also reminded members to participate in the GOMO homeowners survey and to encourage your neighbors to do so; the links are on the GOMO main web page. GOMO Board member James Elmore said the 2025 officer election is on January 15, 2025, and several open board positions need to be filled. He also mentioned the combined efforts by GOCC & GOMO to update contact information for all residents in Garden Oaks.

Russell Etherton from CM Castillo's office reminded people to call both 311 & their office for solid waste pickup com-

plaints. He encouraged attendance of the next townhall in the area at 10AM on February 15, 2025 at St. Rose of Lima. Christina Walsh, liaison for State Representative Penny Morales, will have 2025 calendars at next month's meeting. For anyone interested in knowing how our legislators voted on issues, her office can provide those details.

Mike mentioned that he had received information from CM Kamin's office regarding new focus by the City on Short Term Rental (STR) Regulations. If residents have opinions or feedback about STRs (for example Airbnbs), they can access a form at www.houstontx.gov/ara/business-licensing.html.

Mike then opened the floor for discussion.

The meeting adjourned at 7:55 PM so we could enjoy a holiday dinner, sponsored by GOCC, and prepared by Mickey Morales, with desserts by Angela Winston's Liberation Gluten Free Bakery.

### Recycling Dos and Don'ts

### Excerpted from houstontx.gov/solidwaste/recycling

### The city of Houston recycles:

- Metal and cans: aluminum cans, vegetable cans, fruit cans, coffee cans (all emptied and rinsed)
- Cartons: Both gable top and shelf-stable food and beverage cartons. Examples include milk cartons, juice cartons, soup cartons, soy milk/alternative milk cartons (all emptied and rinsed)
- Glass: Bottles, jugs and jars only (all emptied and rinsed, no lids)
- Paper: Newspaper, magazines, catalogs, junk mail, office paper
- Cardboard: Cardboard and cereal boxes (emptied of packing materials and flattened)
- Plastic: Bottles, tubs and jugs #1 5 and 7. Examples include water and soda bottles, milk jugs, yogurt cups, margarine tubs, detergent bottles, shampoo bottles. (emptied and rinsed). Do not recycle the plastic bottle caps.

Download the HTX Collects app to find out when your recycling day is.

Do NOT put these in the green recycling bin:

- Shredded paper
- Batteries and electronics
- Food/Liquids
- Trash and Bagged Recycling
- Scrap wood and metal
- Yard waste
- Pizza boxes and soiled paper plates and napkins
- Plastic dry cleaning bags
- Bottle caps







### Mulching Beds

So many mulching options, and what is the "right" way? The good news is that there isn't a single right way, and many different ways work well. It depends on your goals and how much time and money you want to spend. Nature does a terrific job with the accumulation of leaves, and you can take a cue from that. Rake up your leaves and pine straw and layer down several inches around your prized plants. It looks fine, is great for plants, and you cannot beat the price. If you want to go whole hog and use your mulching program to minimize weed growth, supplement soil, reduce water needs and protect from excessive heat, there are better options. All of these are important to keeping our pocket parks looking sharp without breaking the bank. Here is the recipe:

- 1. Initial weed removal
- 2. Cover bare soil with 1-2 layers of cardboard.
- 3. 3-4" of hardwood mulch
- 4. Top with 3-4" of pine straw

Applied at any time of the year, it will last at least a year. Repeated yearly, we find that it reduces the time spent in weeding as much as ten-fold.

Below is some excellent information excerpted from thespruce.com that gets into the advantages of mulch and pine straw and discusses it from an either-or perspective. Other than cost, there are no benefits to only doing one or the other and in fact using both does a better job of building nutrition and keeping the mulch in good shape longer.

Pine straw mulch is made from fallen pine needles. After the pine needles have dried, they become pine straw. Pine straw can be used as a yard or garden mulch, much like wood mulch, straw, or shredded leaves.

Pine straw mulch and straw mulch are different. Pine straw mulch is made from pine needles, while straw mulch is made from wheat or oat stems.

#### Benefits of Pine Straw Mulch

- Dense: Pine straw mulch holds tightly together to form a dense layer that holds in moisture and moderates soil temperature.
- Porous: Despite its density, pine straw mulch remains porous enough for water to easily soak through.
- Loose: Pine straw mulch remains loose and light even after it has been installed. It is easy to redistribute pine straw mulch if needed.
- Attractive: Pine straw needles are thin and brown or light red, an attractive complement that fits the look of most yards.
- Stable: Pine straw mulch's needles weave together, forming a stable mat that is difficult to wash or blow away.
- Inexpensive: Pine straw mulch can be produced from your own pine trees, for free pine straw mulch.

#### Pine Straw Mulch vs. Other Mulches

Mulches are either organic or inorganic. Organic mulch is derived from living things and imparts nutrients into the soil. Inorganic mulch, such as gravel or shredded rubber, conserves moisture and preserves existing soil nutrients, controls soil temperature, and limits weed growth. But inorganic mulches do not provide nutrients to the soil.

### **Organic Mulches**

Shredded bark mulch: Shredded bark mulch is sourced from a variety of trees and comes in colors such as red, black, and brown. Shredded bark mulch decomposes slowly and lasts longer than some other organic mulches.

Wood bark: Larger than wood chips, wood bark mulch is made from hardwood waste. The large nuggets are an attractive ground cover, but they do have a tendency to form into an impenetrable mat that hinders plant growth.

**Wood chips:** Pruning trees or cutting down trees produces fine wood chips. Wood chips work well in areas with heavy foot traffic. (continued on page 12)

**Compost:** As organic materials decompose, they turn into a rich, dark soil-like material called compost. Compost is an excellent source of nutrients for plants and can be worked into the soil to improve its structure.

**Straw:** The dried stalks of wheat, rice, or oats are often used for mulch. Straw is an affordable and readily available mulching material and is good for covering large areas.

**Leaves:** Fallen leaves can be shredded and used as mulch. Like compost, leaves are an excellent source of organic matter and can help make dense soils more porous.

### **Inorganic Mulches**

**Rubber mulch:** Recycled rubber from tires and other sources is shredded and can be used as a long-lasting and low-maintenance mulch. Rubber mulch is an excellent choice for playgrounds or driveways.

**Gravel or rocks:** Best used as decorative mulch, gravel or rocks can be used in garden beds or around trees. Gravel helps retain moisture in the soil. Because gravel and rocks are inorganic, they do not decay.

**2024-2025 Constable Contract** - The FY2025 rate is \$124,100 and GOCC's portion is \$99,280 (80%). This covers one deputy at 40 hours per week. FUNDS are Important!



### Recipe for a Brunch Classic

### Kala Dunn, GO resident

At the recent Azalea Street Extravaganza, I shared a table with Plonk! Bistro owner Scott Miller and GO residents M'lissa and Craig Dilley. We got great feedback on the handmade buttery biscuits topped with warm brie, French ham, and honey that we served, and I thought I'd share the recipe here. Whether you tried Plonk! Biscuits at the Azalea Street event or not, freshly baked biscuits are a wonderful addition to any brunch and a generous, if somewhat messy and time-consuming, way to welcome houseguests or family members to a memorable morning.

### Plonk! Buttermilk Biscuits (makes 9 large biscuits)

3 2/3 cups all purpose flour, plus more to flour work area

4 Tablespoons baking powder

½ teaspoon baking soda

2 teaspoons Kosher salt

12 Tablespoons cold, unsalted butter (1 ½ sticks), plus more for brushing on top of biscuits

2 cups cold buttermilk

Sift together dry ingredients (flour, baking powder, baking soda, and salt) into a bowl. Cut butter into ½ inch cubes and cut into dry mixture. (This can be done with a pastry cutter inside the mixing bowl, with your hands, or by transferring the dry mixture to a food processor, adding the butter, and pulsing 10-15 times. Any of those methods work, as long as the result is a crumbly mixture with pea-sized chunks of butter.)

Pour in cold buttermilk and mix just until the dough comes together – be careful not to overmix, or the biscuit will be lacking in flakiness!

Pre-heat oven to 350° F. Dust flour onto clean work surface and turn the mixture out of the bowl. With clean, floured hands, press the dough into a square about the size of a vinyl record cover. Use a spatula or scraper to fold the two outer thirds of the square in toward the center, overlapping with each other and the center third as if you were folding a sheet of paper to place into an envelope. Then use a floured rolling

pin to press the dough back out into a square and repeat the folding process two to three more times. The dough will be shaggy and difficult to handle the first time you fold it but it will become easier to work with each time you fold it. Finally, press the dough into a final, neat square. Cut into nine equally sized squares or use a round cutter for circular biscuits. Place the biscuits onto either a greased and floured sheet pan, a waxed baking sheet, or a silicone baking pad. Be sure to use a pan that can fit into your freezer or divide into smaller pans, because the next step is to place the biscuits into the freezer for ten minutes to firm them up before baking – this is a crucial step, so don't skip it! Once the biscuits are firm, brush them with melted butter and bake for 20-24 minutes – be sure to watch for hot spots and turn the pans accordingly! Enjoy!

And if this all sounds like too much work for you, watch social media for Plonk!'s next Sunday Morning Biscuit Pop-Up! We serve them hot and ready with flavorful toppings, including classic Sausage Gravy -- another recipe for another time!
